PRICE: Prices quoted are CASH prices and per person in US dollars and are based on fares and costs in effect at the time of publication. TRANSPORTATION: Via jet economy class on Air Canada airlines (30 seats confirmed 1st come 1st serve.) Tickets must be completed 45 days prior to departure. Tickets cannot be changed once issued. NOTE: Passengers may arrange their own air & pay the ground price. Passengers doing their own air MUST meet the group at the airport or hotel.

DEVIATIONS/STOPOVERS: An individual change is a deviation from the basic group itinerary will **NOT** be allowed.

HOTELS: Four & five-star hotels throughout. Prices are based on two persons sharing a twin-bedded room with private bath. Single rooms are subject to availability for an additional cost of **\$1450**. If a passenger cannot supply a roommate and Discovery Cruises and Tours is unable to do so, or your roommate cancels before departure, the passenger will have to pay the supplemental charge. (You may be billed after the final payment date for single room accommodations as necessary.)

REGISTRATION & DEPOSIT: A deposit of \$500 per person is required at the time of registration. The deposit may be charged to your VISA, MasterCard. Registrations received inside ninety (90) days must be accompanied by full payment. A \$30 LATE REGISTRATION fee will be assessed.

PAYMENTS: After you have registered for a tour, you will receive an invoice with final payment amount and date due. Final payments should be made payable to DISCOVERY CRUISES AND TOURS and must be received ninety (90) days prior to departure. Final payments received inside ninety (90) days will be assessed a \$30 LATE PAYMENT fee. 

GROUP PROGRAM

DAY 1: - DEPARTURE: Depart Houston to Tel Aviv via Toronto on Air Canada Airlines.

DAY 2: - TEL AVIV / NETANYA:

We continue to Tabgha and the Mt. of the Beatitudes before arriving at Kibbutz En Gev for a lunch of St. Peter's fish. Later, we will visit Capernaum with its ancient synagogue then to Chorazim. We conclude our day with baptism in the Jordan River. Overnight Tiberias. (B, L, D)

DAY 5: - CAESAREA PHILIPPI / GOLAN HEIGHTS: This morning we travel to Gamla, the site of a Jewish city founded in the 2nd century, then we visit El Rom OZ77 movie about the battle at the Valley of Tears in the YOM KIPPUR WAR and Caesarea Philippi, the Golan Heights and view Mt. Hermon before visiting Tel Dan. Overnight in Tiberias. (B, L, D)

DAY 6: - Bet Shean / En Harod / Dead Sea: This morning we start early traveling south through the Jordan Valley to the city of Bet Shean. We then visit Gideon's Spring at En Harod and a visit at Kasr El Yehud, the baptismal site of Jesus in the Jordan River before continuing south along the shore of the Dead Sea on the lowest road in the world. We arrive at a beautiful Dead Sea hotel for the balance of the day to relax at the hotel pools, Dead Sea spa, mineral pools or to enjoy other special services. Overnight at the Dead Sea. (B, L, D)

DAY 8: - JERUSALEM / MOUNT OF OLIVES / GETHSEMANE / OLD CITY: Today we drive to the top of the Mount of Olives for a view of Jerusalem before taking the Palm Sunday pathway to Dominus Flevit, the place Jesus wept over Jerusalem. We continue down the mountain to the Garden of Gethsemane and have a very special time of prayer and worship in a private garden. After lunch, we visit the Israel Museum with the Model City and the Dead Sea Scrolls. We end the day at Yad Vashem, the Holocaust Museum. (B, L, D)

DAY 9: - OLD CITY / WAILING WALL / TEMPLE MOUNT: We start the day with a visit to the Temple Mount where the first two Jewish temples stood. We walk through the Old City visiting the Lion's Gate, the Pool of Bethesda, the Church of St. Anne, and Antonia's Fortress where we stand on the actual pavement stones where Jesus was judged by Pilate. After lunch, we visit Friends of Zion Museum and Mahane Yehuda open-air Market. (B, L, D)

DAY 10: - OLD CITY / SOUTHERN WALL EX-CAVATIONS: This morning we visit the Zion Gate, Temple Institute, the Jewish Quarter, Southern excavations of the Second Temple period. We end the day at the House of Caiaphas where Jesus was held His last night before His crucifixion. (B, L, D)

DAY 11: - JERUSALEM / GARDEN TOMB:

This morning we visit the Garden Tomb for an exciting time of prayer and worship. After lunch, we visit the Valley of Elah where David slew Goliath and time permitting, the ancient city of Emmaus. (B, L, D)

DAY 12: - TEL AVIV / HOME:

We depart Tel Aviv for our flight to Houston (IAH) via Toronto.
